SWEEPSTAKES ELIGIBILITY:

Entrants must be legal residents of the 50 United States, 18 years of age or older, and complete the following actions below in order to enter and take part in this Sweepstakes.

HOW TO ENTER / EXECUTION:

Readers of www.HelloBeautiful.com must do the following:

1. Visit www.hellobeautiful.com ("Participating Website").
2. Upon entering the Participating Website, Visitors will be prompted to use RaffleCopter's widget in order to enter Sweepstakes, however, Visitors may elect to use the alternate means of online entry described below.
