SWEEPSTAKES ELIGIBILITY:

Entrants must be legal residents of the 50 United States or the District of Columbia, 18 years of age or older, and complete the following actions below in order to enter and take part in this Sweepstakes.

HOW TO ENTER / EXECUTION:

Readers of www.hellobeautiful.com must do the following:

1. Visit www.HelloBeautiful.com (“Participating Website”).
