This Sweepstakes will be conducted exclusively online. One (1) winner will be awarded One Thousand Dollars USD (\$1,000.00) ("Prize"). Prize approximate retail value ("ARV") is \$1,000 USD. Total Sweepstakes ARV is \$1,000.

SWEEPSTAKES ELIGIBILITY:

Entrants must be legal residents of the 50 United States or the District of Columbia, 18 years of age or older, and complete the following actions below in order to enter and take part in this Sweepstakes.
